Kenneth M. Warren Jr., Esq., of Leonard, Warren & Leonard LLC, serving as Solicitor for the Township of Hamilton and on behalf of the Defendant, Hamilton Township Police Department, located at 6101 13<sup>th</sup> Street, Mays Landing, New Jersey 08330, responds in opposition of Plaintiff's request of an Order to Show Cause with Temporary Restraints as follows:

1. On or about November 29, 2025, Plaintiff was operating a Black Volkswagen in the Township of Hamilton and was stopped by the Hamilton Township Police Officer(s) after the observation of tinted front windows, no front license plate, and for careless driving;
2. At the time of the lawful traffic stop, Plaintiff's driver's license was suspended/revoked, the motor vehicle was not insured and properly registered;
3. Plaintiff admitted to officers that he did not have a valid driver's license, that he did not have insurance as the vehicle was "insured by God," and did not have the valid paperwork necessary to lawfully operated the motor vehicle;

4. Pursuant to applicable New Jersey Statutes, officer(s) towed and impounded the motor vehicle;
5. Plaintiff failed to cooperate with lawful commands by the officer(s) and was detained;
6. Plaintiff was lawfully issued summons for the following traffic/criminal offenses on November 29, 2025 in the Township of Hamilton by the Hamilton Township Police Department (*See Exhibit A*):
  - (a) **Ticket E25 030715 0180:** Driving After Driver's Licensed/Registration is Suspended/Revoked contrary to N.J.S. 39:3-40;
  - (b) **Ticket E25 030716 0180:** Failure to have Inspection contrary to N.J.S. 39:8-1;
  - (c) **Ticket E25 030717 0180:** Failure to have Liability Insurance Coverage on a Motor Vehicle contrary to N.J.S. 39:6B-2;
  - (d) **Ticket E25 030718 0180:** Safety Glass Requirement Violation contrary to N.J.S. 39:3-75;
  - (e) **Ticket E25 030719 0180:** Careless Driving contrary to N.J.S. 39:4-97;
  - (f) **Ticket E25 030720 0180:** Improper Display/Unclear Plates contrary to N.J.S. 39:3-33;
  - (g) **Summons SC 006813 0180:** Disorderly Conduct contrary to N.J.S. 2C:33-2;
  - (h) **Summons SC 006812 0180:** Obstruction contrary to N.J.S. 2C:29-1; and
  - (i) **Summons SC 006814 0180:** Resisting Arrest contrary to N.J.S. 2C:29-2.
7. At the time of the incident/arrest, the vehicle (Volkswagen Passat) operated by the Plaintiff was impounded as a result of the above referenced violations pursuant to applicable New Jersey Statutes;
8. The reference motor vehicle is currently impounded at Dirkes Auto, LLC located at 6935 Black Horse Pike, New Jersey 08330;
9. The motor vehicle is releasable upon providing a valid driver's license, valid registration, proof of valid liability insurance in accordance with applicable NJMVC regulations, and payment of outstanding tow/impound fees;
10. As of December 19, 2025, the above referenced motor vehicle has not been retrieved from Dirkes Auto LLC and has accrued fees in the amount of \$932.97 (*See Exhibit B*);
11. As of December 19, 2025, Plaintiff has not provided proof of a valid driver's license, valid registration, proof of valid liability insurance in accordance with applicable NJMVC regulations.

12. Pursuant to N.J.S. 39:3-40.3, a motor vehicle subject to the provisions of this act may be impounded by any law enforcement officer if the registrant:
  - (a) Knowling permits an unlicensed driver to operate a motor vehicle;
  - (b) Operates or permits the operation of that motor vehicle without a valid temporary registration or valid temporary registration plates as authorized under section 3 of P.L.1995, c.286 (C.39:3-40.2); or
  - (c) fails to surrender a registration certificate and registration plates in accordance with the provisions of subsection b. or c. of section 2 of P.L.1995, c.286 (C.39:3-40.1);
13. Additionally pursuant to N.J.S. 39:3-40.3, a motor vehicle impounded under the provisions of this subsection shall be removed to storage space or garage and its registration certificate and registration plates seized. The registrant shall be responsible for the cost of the removal and storage of the impounded motor vehicle;
14. Pursuant to N.J.S. 39:6B-2, law enforcement may also lawfully impound a motor vehicle that is operated or caused to be operated in the State of New Jersey without the requisite liability insurance coverage;
15. Pursuant to N.J.S. 39:3-4, “Any police is authorized to remove any unregistered vehicle from the public highway to a storage space or garage, and the expense involved in the removal and storing of the vehicle shall be borne by the owner of the vehicle, except that the expense shall be borne by the lessee of a leased vehicle.
16. Pursuant to N.J.S. 39:3-40.6, *“no motor vehicle which has been impounded pursuant to the laws of this State shall be released by the State or local law enforcement authority which impounded the vehicle unless proof of valid motor vehicle insurance for that vehicle is presented to the law enforcement authority.”*
17. In accordance with *Crowe v. DeGioia*, 90 N.J. 126 (1983) Plaintiff is required to satisfy the four prongs a New Jersey Court may consider where injunctive relief is sought:
  - (a) it is necessary to prevent irreparable harm;
  - (b) the legal right underlying the application is unsettled;
  - (c) the applicant has made a preliminary showing of a reasonable probability of ultimate success on the merits; and
  - (d) the relative hardship to the parties in granting or denying the application.
18. Plaintiff has been able to retrieve his vehicle at any time upon providing a valid driver’s license, valid registration, proof of valid liability insurance in accordance with applicable NJMVC regulations, and payment of outstanding tow/impound fees and therefore this Order to Show Cause should not be granted as there is no irreparable harm;
19. As Defendant lawfully impounded Plaintiff’s vehicle and assessed costs pursuant to N.J.S. 39:3-40.3, 39:6B-2, 39:3-4, 39:3-40.6 and relevant case law, Plaintiff has failed to make a preliminary showing of a reasonable probability of ultimate success on the merits; and

20. Pursuant to N.J.S. 39:3-40.6, the motor vehicle cannot be released *unless proof of valid motor vehicle insurance for that vehicle is presented to the law enforcement authority.*

Therefore, Defendant through the undersigned counsel respectfully request that the Plaintiff's request for temporary restraints be dismissed and allow the statutory time to file any appropriate answer and/or counterclaim to the pending Complaint.






