**CERTIFICATION OF PUBLIC-

AND RULE-BASED COMPLIANCE

*(Submitted to Prevent Improper
Adjournment or Invalid-Service Finding)*

I, **Devon Tyler Barber**, of full age, hereby certify as follows:

1. I am the Plaintiff in the above-captioned matter and submit this Certification based on personal knowledge.
2. On **December 16, 2025**, the Superior Court entered an **Order to Show Cause with Temporary Restraints** in this matter and directed that it be served upon Respondents and custodians.
3. **That same day**, I served the signed Order to Show Cause by **electronic mail** upon **Hamilton Township and the Hamilton Township Police Department** using **official .gov email addresses publicly posted by the Township and HTPD for governmental contact**, including administrative, records, Internal Affairs, and executive offices.

4. These email addresses are maintained on the Township's and Police Department's official **.gov websites** and are expressly held out to the public as appropriate channels for official communications. Service through these addresses was **reasonably calculated to provide notice and did provide actual notice**. See Exhibit A.
5. I also served **Dirkes Auto LLC d/b/a Dirkes Used Auto Parts / Dirkes Towing**, the known commercial custodian of my vehicle, using sales@dirkesauto.com, an email address **publicly advertised on Dirkes' commercial website for business communications**, for business communications. See attached Exhibits B-1, B-2, and B-3, confirming that the commercial entity publicly advertises this electronic mail address as a designated business contact.
6. Use of a business's publicly designated commercial email address constitutes notice reasonably calculated to reach the custodian responsible for the vehicle that is the subject of this proceeding.
7. In addition to effectuating service, I **filed a Proof of Service through the New Jersey Judiciary Electronic Document Submission system (JEDS) on December 16, 2025 at 11:43 a.m.**, which was **accepted and docketed by the Court** under the following official metadata:
 - Court / Division: Superior Court of New Jersey – Civil
 - Docket / Case Type: L
 - Venue: Atlantic County
 - Filing Type: Proof of Service

8. The Proof of Service filed under **Transaction ID EF-3827675** was **accepted by the Court**, was **not rejected, struck, or marked deficient**, and **no order has been entered finding service defective or invalid**. The Court's docket therefore reflects **timely, court-recognized proof of service** prior to the scheduled return date.
9. As a result of the service described above and the filed Proof of Service, **Hamilton Township, the Hamilton Township Police Department, and the vehicle custodian have had explicit and actual notice of:**
 - (a) the Court's Order to Show Cause and Temporary Restraints;
 - (b) the identity of the vehicle and its custodial status;
 - (c) my indigent status, previously recognized by the Court; and
 - (d) the **December 22, 2025 return date**.
10. This matter involves the **ongoing deprivation of essential personal property**, including a vehicle, work tools, personal identification documents, winter clothing, and work gear, seized **without prior adjudication**, with **continuing irreparable harm**, including compounding fees and loss of access to work, housing stability, and basic necessities.
11. The purpose of service under New Jersey law is **notice**, not technical form. Where actual notice has been achieved, **technical objections do not defeat service**, particularly in emergent and equitable proceedings. **Courts routinely decline to elevate form over substance where notice has been achieved and no prejudice is shown.**
12. Pursuant to **Rule 1:1-2**, any procedural rule may be relaxed where strict adherence would result in injustice. I have acted **promptly, diligently, and in good faith**, and any claimed technical defect—if one were found—has been cured and cannot justify adjournment.

13. I am a **New Jersey resident currently receiving emergency assistance**, seeking judicial review of a seizure that should not have occurred. **Rescheduling this matter to January based on a technical service argument would perpetuate irreparable harm without advancing justice.**
14. I submit this Certification to make the record clear that **service was valid, notice was actual, and the Court has full authority to proceed on December 22, 2025.**

I certify that the foregoing statements are true. I am aware that if any statement is willfully false, I am subject to punishment.

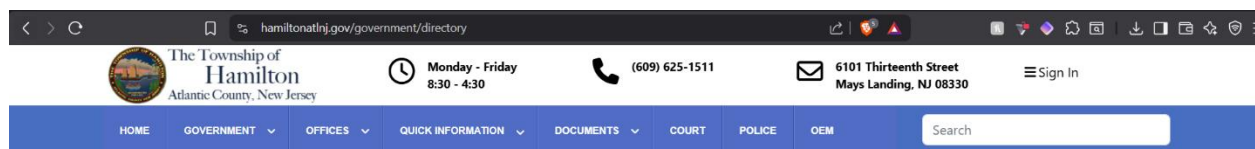

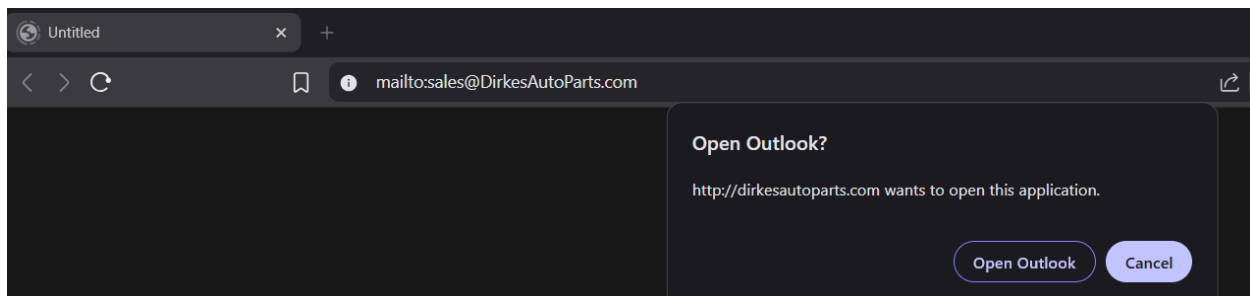
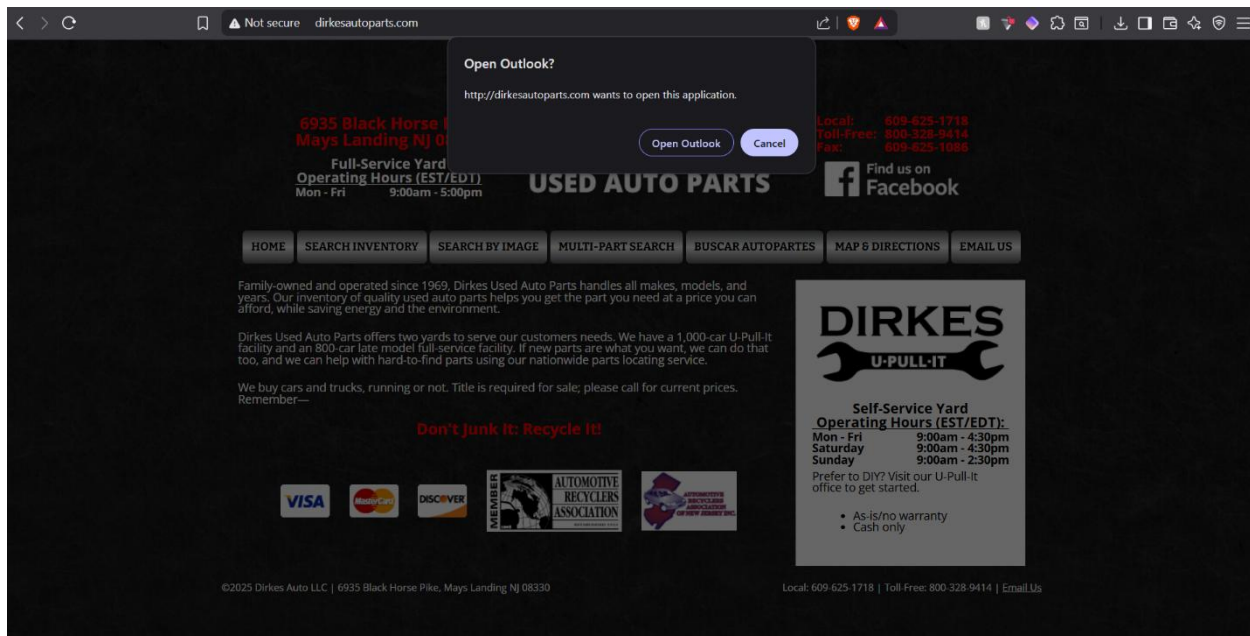
